1. *The Chainpur Municipality, Chainpur, Sankhuwashava* invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of *sabha khola solar Mus Chainpur-11* under National Competitive Bidding procedures. The estimated amount for the works is Rs. 1,42,40,818.6 (Including VAT).
2. Eligible Bidders may obtain further information from the office of *Chainpur Municipality, Chainpur, Sankhuwashava* or may visit PPMO website www.bolpatra.gov.np/egp.
3. Bidders have only the option to submit their bid electronically should download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost Rs. 3000 of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall not be held .
5. Last Date of bid purchase is 30 days from date of bid publication in office time .
6. Sealed or electronic bids must be submitted to the office of *Chainpur Municipality* through PPMO website www.bolpatra.gov.np/egp on or before **12:00 hrs of 2077/12/13**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hrs of 2077/12/13** at the office of *Chainpur Municipality, Chainpur, Sankhuwashava*. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs.3,75,000|-.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. *The purchaser* reserves the right to accept or reject ,wholly or partly any or all the bid without assigning any reasons whatsoever .
10. Matters not covered by this notice shall be in accordance with Public Procurement Act 2063 and Public Procurement Regulation 2064 and other prevailing rules and regulations of Nepal.
